## DAY BY DAY ITINERARY

**Day One-Monday:** Depart New York City for Israel.

**Day Two-Tuesday:** Arrive Israel at Dinner Time for an overnight on the shores of the Mediterranean Sea.

**Day Three-Wednesday:** Spend the morning exploring Herod's masterpiece city, Caesarea and see where Paul was put on trial. Visit the top of Mt. Carmel and witness where Elijah prayed the fire down from heaven. We'll We'll drive through Jesus's boyhood town of Nazareth on the way see the Sea of Galilee from atop Mt. Arbel. Overnight: Northern Galilee.

**Day Four-Thursday:** We'll start our day in lush forests of the ancient city of Dan, even seeing a gate from Abraham's time. We'll hear Jesus' teaching at Caesarea Philippi about the birth of the Church. This afternoon we'll meet our Pastor and staff for an afternoon of orientation for ministry in Israel. Overnight in Northern Galilee

**Day Five-Friday:** Today we'll spend the morning on Jesus' home turf. After A boat ride on the Sea of Galilee, we'll visit Jesus' hometown of Capernaum, and visit Magdala to see the synagogue in which He taught. We'll finish our day going to a Shabbat service with our brothers and sisters and experience worship in the Holy Land. Overnight: Northern Galilee.

**Day Six-Saturday:** We'll spend the day in service on mission with Grace for Israel. Learning and serving the people of the Galilee for a day of fulfillment of our purpose. "Behold how good and pleasant it is for brothers to dwell together in unity." – Psalm 133:1. Overnight: Northern Galilee.

**Day Seven-Sunday:** We'll say goodbye to our ministry team and travel from the north Israel all way down to the south. Driving along Jordan River valley we'll stop in Beth Shean, the Old Testament town where King Saul was killed, and the most impressively excavated example of a Roman City from New Testament times in the whole of Israel. We'll stop along the Jordan River and see where the Israelites crossed over, where Elijah was transported up to heaven, and where Jesus was Baptized, all en route to our stay on the shores of the Dead Sea. Overnight: Ein Bokek.

**Day Eight-Monday:** This morning we will travel by cable car to the top of the ancient fortress of Masada. Then we'll visit En Gedi, where David hid from King Saul. We'll discover Qumran where the Dead Sea Scrolls were found before continuing up to a spectacular overlook of the Holy City of Jerusalem before heading to our Hotel. Overnight: Jerusalem.

**Day Nine-Tuesday:** We'll begin our exploration of Jerusalem today with a walk down the Mt. of Olives, retracing the steps of Jesus on Palm Sunday, and ending our walk in the Garden of Gethsemane. The afternoon will be an option for you to spend time with us at the Israel Museum seeing ancient artifacts, the Temple model, and the Dead Sea Scrolls; or, you may have the afternoon to yourself for shopping or rest.

**Day Ten-Wednesday:** We start our day on the Temple Mount, the most holy site in the world. We'll explore the Southern Steps where Jesus walked, the Western Wall from both atop and in the tunnels below the ground. And see the City of David up close and personal. There's even an option to wade through Hezekiah's tunnel, ending at the Pool of Siloam.

**Day Eleven-Thursday:** Our last day in country finds us at Yad Veshem, the Holocaust Museum. Then a visit to the Old City for lunch and shopping, and a visit to the Holy Sepulcher Church, ending with a communion service at the Garden Tomb. Then a farewell dinner and a late-night flight home.

# TERMS AND CONDITIONS

**Tour prices:** All prices in this brochure are based on airfares, land rates and exchange rates in effect at the time of printing and on group rates of 30 passengers or more. Tours may depart with less than the required number of passengers, at the discretion of Group IST, LLC (doing business and referred to herein as "Journeys Unlimited"), but an additional charge may apply. Passengers will be advised about such surcharges 60 days before departure. All prices are subject to change without notice prior to departure due to major currency fluctuations, changes in fuel prices and/or unforeseen economic circumstances.

**Reservations, Deposits and Final Payments:** Please complete the Participant Agreement, with full names as they appear on passports, and mail it to us with the required per person deposit plus applicable (optional) insurance. Receipt of your deposit shall act as your agreement to these terms and conditions. Balance is due 60 days before departure date. If final payment is received less than 60 days, a late fee will be assessed in the amount of \$50.00. If final payment is made by credit card (American Express, Visa, MasterCard), Journeys Unlimited requires a completed credit card authorization form. All payments made by check should be made payable to Journeys Unlimited.

**Late Reservations:** If a booking is made within 60 days of departure, full payment plus applicable taxes and optional insurance is due at the time of booking. There will be a \$50.00 late processing fee applicable plus cost of any express or overnight mail services. No personal checks will be accepted with reservations received 30 days or less before departure date. Money order, bank check, certified check or credit cards (American Express, Visa, and MasterCard) will be accepted.

**Travel Documents:** A valid passport (valid for six months after the return date of the trip) is required to travel. Visa is required for US passport holders traveling to some destinations; please contact our office for details. All non-US citizens must contact the appropriate consular office for entry visa requirements pertaining to their trip. In addition non US citizens are responsible for complying with requirements for re-entry into the USA. Journeys Unlimited assumes no responsibility for procurement of passport or visas. Obtaining and carrying these documents is the sole responsibility of passengers. Journeys Unlimited will not be responsible for any delays, damages and/or losses, including missed portions of your trip due to improper travel documentation.

**Final Documents and Tickets:** All documents and tickets are only issued upon receipt of final payment and are sent within 3 weeks of departure. Documents and tickets are not guaranteed if final payment and booking form are not received on time.

**Air from Home City:** All brochure departures are based on a New York area airport. Journeys Unlimited can help arrange air transportation from your home city airport. Journeys Unlimited is not responsible for any penalties incurred on domestic tickets not purchased from us, in case of changes in the schedule of the tour. If you are making your own domestic airline tickets, please make sure that your domestic flight time arrives at least 4 hours prior to your international departure time.

**Air Changes, Cancellations & Refunds:** Airline tickets issued by Journeys Unlimited are highly restrictive and in most instances cannot be reissued, revalidated or exchanged. If a change is possible, a \$75 per person administrative fee, plus any applicable airline change fees, will be assessed once air tickets have been issued. Airline penalties vary depending on carrier.

**Airline Seat Assignments and Special Services:** There is no advance seat selection. Early check-in is necessary to secure seats with travel companions. Seating is solely under control of the airlines. Some airfares used may be eligible for frequent flyer mileage.

**Baggage:** The company is not responsible for any additional charges collected by the carriers at the airport for luggage fees. We recommend that you take along one suitcase per person with a maximum weight of 50lbs., plus one carry on with maximum dimensions of 9"X14"X22". Airlines also have their own baggage restrictions; please check with the air carrier prior to your departure. All baggage is the passenger's responsibility throughout the tour. Journeys Unlimited is not responsible for loss, theft or damage to your baggage. If a bag is lost or damaged in-flight, the passenger is responsible for notifying the airline directly.

**Airline Clause:** The airlines concerned will not be held responsible for any act, omission, or event during the time passengers are not aboard their aircraft. The passenger tickets in use by the airline, when issued, shall constitute the sole contract between airline and the purchaser of these tickets and/or passenger. These tours may be sold in connection with the services of any ATC or IATA Airline.

**Rooms:** Prices shown in the brochure are per person, based on two persons sharing a hotel room or cabin. A limited number of single rooms are available at the supplement shown per tour. In some cases, when requested, we may be able to find an appropriate roommate for passengers who have booked as a single person. Triple rooms are available in many hotels for family or friends traveling together. There are no discounts for triple rooms.

**Land Only Bookings & Tour Deviations:** All Journeys Unlimited packages include airfare from the city designated. Land only bookings will be invoiced based on adjusted price. Arrival and departure transfers are not provided for land only bookings. Any deviations from the tour, requested by the client, will be assessed a charge of \$100.00 per person, plus any additional costs the change may incur.
